Today, organisations need simple solutions to manage and orchestrate their growing security portfolios.

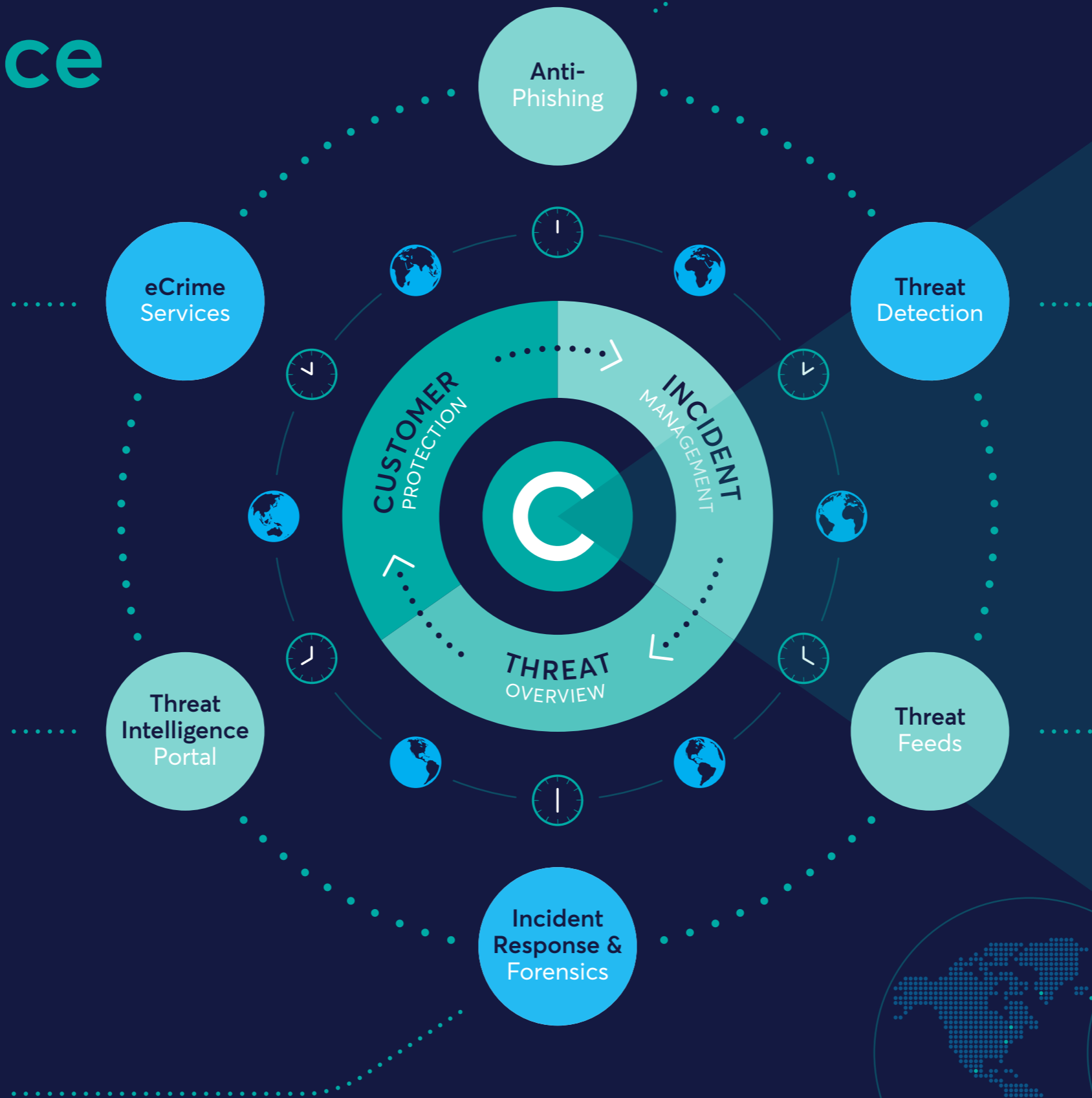

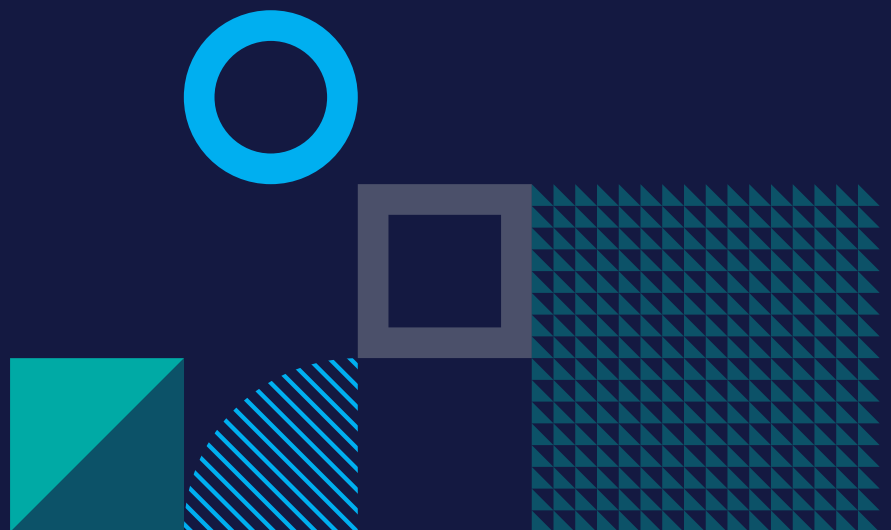
